# POLLUTION INCIDENT RESPONSE MANAGEMENT PLAN

## Koowong and Rockwood Quarries

- A. Hazards Identified**  
Fuel spill, oil spill, fire
- B. Likelihood of hazards occurring**  
Low
- C. Action taken to control, minimise or avoid hazard**  
~~Overhead storage of fuel~~ and minimal storage of oil in 20L containers.  
~~Overhead storage area is bunded~~ No bulk fuel stored on site.
- D. Quantity and location of pollutants**  
Fuel – ~~500L~~ Oil – 100L  
~~Fuel is stored in overhead tank and~~ working machines contain engine and hydraulic oil. No Bulk storage of fuel on site – tank decommissioned
- E. Safety equipment to control risk**  
Spill kits and sand to control fuel and oil flows.  
Fire extinguishers for fire fighting.  
Earth bund around overhead storage tank.
- F. Detailed description of action to be taken in the event of fuel or oil spills**
1. Contain spill to the immediate area by forming an earth bund with available gravel and crushed rock.
  2. Soak up any liquids using spill response kit.
  3. Ensure that no fuel or oil is allowed to enter any stream or river.
  4. Load any contaminated soil or material onto a truck and transport to council landfill for proper disposal.
  5. Advise your supervisor or manager of the incident at the first opportunity.
  6. Advise the EPA at the first opportunity.
